On the establishment of the International Scientific-Research Clinical And Educational Centre
Of Regenerative Medicine and The Establishment Of The Departments' Working Groups

In order to implement the scientific research in the area of regenerative medicine in the context of the monetary grant of the Government of the Russian Federation №11.G34.31.0065 designed to support of the scientific research, carried out in The State Budgetary Institution Of Higher Professional Education “The Kuban State Medical University” Of The Ministry Of Health Care And Social Development Of The Russian Federation (hereinafter – the University) under the guidance of the leading scientist, on the direction “The study of molecular mechanisms and main directions of the development of new approaches in the area of regenerative medicine and bioengineering of pulmonary and airway tissues for clinical use” it is hereby ordered:

1. To found on the basis of the University a scientific commonwealth – the International Scientific and Research Clinical and Educational Centre of Regenerative Medicine (hereinafter – the Centre) in order to implement the monetary grant of the Government of the Russian Federation.
2. To appoint Paolo Macchiarini as a head of the Centre.
3. To approve:
 - The provision on the International Scientific-Research Clinical And Educational Centre Of Regenerative Medicine (Appendix 1);
 - The structure of the functional directions of the Centre activities and the list of members of the Scientific group (Appendix 2).
4. To approve the list of departments' working groups on the University to assist the implementation of the scientific research in the area of regenerative medicine in the

frame of the monetary grant of the Government of the Russian Federation with the list of spheres of responsibility (Appendix 3).

5. To provide the support of the implementation of the scientific research to all the heads of the University departments on the entrusted directions.
6. To contribute suggestions to vice-principal on the research work A.N.Redko on the disposition of matching funds for the remuneration of the members of the working group.
7. To entrust the overview of the implementation of the present order to vice-principal on the scientific research A.N.Redko, for which reason he should be invested with authority on the consultation and subscription of the report documents, attending the implementation of the grant of the Government of the Russian Federation.
